FINANCIAL CONTRACT

TLE Christian Academy (the “School”) and the Parent(s) or Guardian(s) (the “Parent”) of the enrolling student (the “Student”) who is (are) identified in the Enrollment Form hereby enter into the Enrollment Contract for the school term 2016-2017 subject to the terms and condition outlined below. The School agrees to matriculate the Student in a program of academic instruction appropriate for the Student’s grade level, and the Parent agrees to pay the following tuition and fees. Each Parent/Guardian is jointly and severally responsible for the financial and other obligations of this Contract.

ONE TIME FEES:

- REGISTRATION FEE: \$250 (\$200 before July 1) Registration fee is non-refundable.
- ENTRANCE TESTING \$250 Required for new students only. Entrance testing fee is non-refundable.
- BOOK FEE: \$550 (\$500 before July 15) Book fee is non-refundable.
- PIE FEE \$50 PIE = Parents In Education due August 1, non-refundable

ANNUAL TUITION:

- Elementary School (Grades 1 – 5): \$6.900
- Middle School (Grades 6 – 8): \$8.850
- High School (Grades 9 – 12): \$10.100

INCIDENTALS:

Charges occurring during the school year will be handled as follows:

- **Uniform fees:** Families order them online, link on TLE Website; the uniforms are delivered to TLE Academy and the charges will be put on the family account.
- **Aftercare** is defined as any child not being picked up by 3.45 will be charged a fee. The fee structure is as follows: 3.45-5.00pm: \$10; 5.00-5.30pm: additional \$5; after 5.30pm the family is charged \$2/5 minutes. All charges are put on the account weekly.
- **Field trips, other family events** are charged to the account.

TUITION DISCOUNTS:

- **Multi-Child:** If Parent has multiple children enrolled in the School, multi-child discounts will be applied as follows. The child in the highest grade will receive no tuition discount. The child in the next lower grade will receive a 20% tuition discount. Third and subsequent children will receive a 50% tuition discount. Multi-child discounts are discounts for tuition only and are not applicable to any other fees.
- **Pastor:** If Parent is a full-time Senior Pastor his/her student(s) will receive a 20% tuition discount. Pastor discounts are discounts for tuition only and are not applicable to any other fees.
- **No Multiple Discounts:** If Parent is eligible for both Multi-Child Discount and Pastor Discount, only one discount may be applied.

OTHER DISCOUNTS:

- **Parent workshop discount**
the school will offer five (5) parent workshops during the academic year. For each workshop a Parent attends, Parent will receive a \$60 tuition discount for each Student enrolled. Discount will be paid at the end of the workshop.
- **Financial aid**
a limited amount of financial aid is available for families that qualify. Please see the school administration for further information regarding the financial aid application and award process.

PAYMENT OPTIONS:

For the 2016-2017 school year, the School will have three tuition payment options available. These options are:

1. Pay the balance in **one full payment**, due no later than August 1. Parent will receive a 5% tuition discount. If paid before July 1 an additional 5% will be received.
2. Pay the balance in **two equal payments**, due August 1, 2016 and January 1, 2017.
3. Pay the balance in **ten equal payments** made each month from August 1, 2015 through May 1, 2016.

FINANCIAL TERMS AND CONDITIONS:

All families are to sign up for an account at **SMART TUITION MANAGEMENT**, who manages all payments and reminders/reporting. The moment the family is enrolled they will be reported to SMART who will send an email in which sign up information and other pertinent contact information is established. Certain fees apply for this service such as: initial fee of \$50, Late fee of \$40, and a returned check fee of \$40.

While tuition fees are paid as above, One-time-fees and all incidentals will be handled separately as agreed upon at the time of the cost occurred.

FINANCIAL OBLIGATIONS:

Since the School hires faculty, purchases supplies, and makes other financial commitments on an annual basis determined largely due the strength of enrollment contracts, any Student who withdraws prior to the end of the semester will be charged the tuition for the remainder of the semester.

The obligation to pay the fees for the semester as aforesaid shall constitute liquidated damages and not a penalty or forfeiture. School and Parent hereby agree that the actual damages for breach of the Enrollment Contract and Agreement are impossible to ascertain with certainty and that the amount described above is a reasonable estimate thereof. These rules, as governed by Board policy, apply regardless of the reason of cancellation, whether for absence, withdrawal, dismissal, or otherwise. Tuition payments are not prorated for illness or suspension. Any challenge of these rules should be expressed to the Board of Directors.

OUTSTANDING BALANCES:

Students with outstanding account balances at the end of each semester, see below, may not be considered to continue at TLE Academy, whether going into the second semester or re-enrollment to next year until all accounts are paid in full. In addition, the school reserves the right to withhold grades, diplomas, and transcripts until all accounts are paid. By signing this Enrollment Contract, Parent authorizes School to withhold report cards and other records until tuition and other School fees have been paid in full.
